Highlights Q3/14



Financial Highlights

- Holding Monex reports at September, 2014 accrued operating revenue of \$3,059 million pesos on net income of \$476 million pesos or \$1.21 pesos per share.
- On Sepetember 2014, Holding Monex presented a Book value of \$13.85 pesos per share.
- During 3Q14, Monex International Business had an increase of 14.7% versus same prior year period, with an operating income of \$218 million pesos.

Outstanding Events

- Holding Monex is carrying out several processes in order to issue Stock Certificates for an amount of 1,000 million pesos under the MONEX 14 denomination. This issuance is carried out under the 2012 authorized program for long term stock certificates.
- On October 15th, 2014, Holding Monex entered into a sell contract regarding the total shares of its subsidiary Pagos Intermex as well as Monex Servicios, a Banco Monex subsidiary. Regarding the above, several suspensive conditions are pending to be accomplished in order to concrete this transaction. The sell of Pagos Intermex is performed as a part of the Issuer's strategy to focus it's efforts on financial services.


