Highlights Q3/15

- As of September, 2015, Holding Monex reports accrued operating revenue of \$3,882 million pesos and net income of \$580 million pesos or \$1.08 pesos per share .
- The accrued operating revenue from our National Forex Business amounted \$1,951 million pesos, that represents a 12% increase compared with the amount reported as of September 2014.
- Monex International Business (Monex Europe and Tempus) had an accrued operating income of \$979 million pesos, an increase of 57% versus the same period of the prior year.
- On September, 2015, Holding Monex presented an Equity of \$6,268 million pesos which represents a Book value of \$11.69 pesos per share.
- As of September, 2015, the Loan Portfolio amounted \$11,787 million pesos, an increase of 48% compared with the ammount reported as of December 2014.

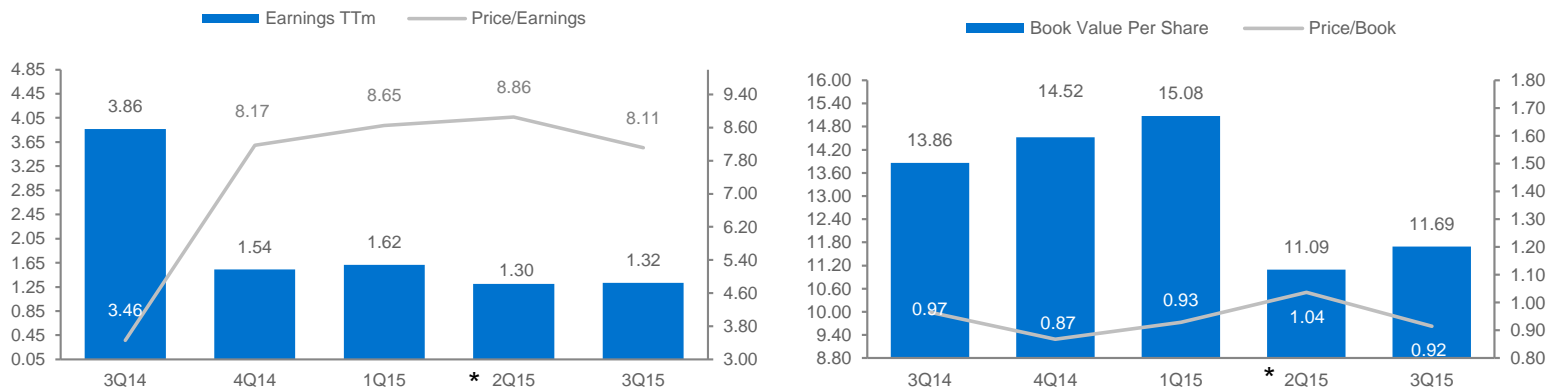
